WITNESSETH, That the said party of the first part, for and in consideration of the exchange and conveyance to it by patent of certain land together with the additional payment to it of the sum of \$23,500.00 by the UNITED STATES OF AMERICA, which land and payment are substantially equal in value to the land described at Exhibit "A" attached hereto and made a part hereof, as authorized by the Act of Congress approved March 20, 1922 (42. Stat. 465), as amended, the Act of Congress dated October 21, 1976 (43 U.S.C. 1716), as amended, and the Federal Land Exchange Facilitation Act of August 20, 1988 (P.L. 100-409; 102 Stat. 1086), the receipt of which consideration is hereby acknowledged, does hereby CONVEY AND WARRANT unto the UNITED STATES OF AMERICA, and its assigns, Forever, two parcels of land located in the Township of Grayling, County of Crawford, State of Michigan, said parcels being more particularly described in Exhibit "A" which is attached hereto and made a part hereof, containing 10 and 25.70 acres respectively for a total of 35.70 acres, more or less together with all appurtenances thereunto belonging or in anywise appertaining.
