 Stand 76, Work with Parks and Recreation Division on specifics within campground regarding stump height and removal. Add follow-up planting within campground, hand plant red pine and white pine mix.

· Stand 81, Drop prescription.

Changes made at compartment review:

- Stands 2, 3, and 32, limit bio-mass harvesting by not allowing chipping of tops. Featured species for this area is American Marten.
- Stand 32, favor wind-firm white spruce at 1 to 3 per acre for retention.
- Stand 27, stand retention rate should be at or near 10%. The featured species in this area is moose.

- Stand 13 and 21, mark 10 inch white birch to be left, if any are present. Featured species for this area is pileated woodpecker.
- Stand 13, 21, and 45, add, yellow birch larger than 18 inches to retention. Prohibit chipping of tops. The featured species in this area is the pine marten.
- Stand 35 and 45, extra care around cedar and hemlock to avoid residual damage.
- · Correct map errors depicting SCA designation.
