Norman Todd McLain- Compartments 3, 23 and 28. I would like to see more active mgmt.. of the areas that have been hit hard by the Oak wilt disease. There are significant sections of state land in the Peacock Twp/Lake county area along 3 mile rd corridor that has a lot of dead pin oaks. Please do not allow the maple/pine components to take over these areas.

David Gregg- Compartment 142 T22N R9W section 24-25. I am 68 years old and used to hunt this property. Since the road closing I am no longer able to walk the distances. I am against the closures in general which make access to public land difficult or in many cases impossible. This has happened on many public lands. In this particular case closure appears to have been done to benefit current or former DEQ/DNR employees. With the treatments done this year or next I would like to see the road re-opened to provide access to the parcel for all hunters. The northwest corner of the property should also be established if it has not been.
