## **Comments from Stakeholders**

PRD and FRD held a joint open house/public meeting on September 14, 2015 in the Sault to discuss harvest treatments and ski trail maintenance of the Algonquin Ski Trail. Five members of the public attended.

The Open House at the Naubinway Field Office on September 16, 2015 had zero people attend. An additional Open House at the Kinross Township Hall September 17, 2015 had six people attend. Attendees viewed maps and data, and discussed management prescriptions with staff. One comment sheet was filled out concerning the availability of ash for craft purposes.

Three letters were received: one regarding management in C18 on Drummond Island and concern with harvesting near Cornbeef Junction, one from Ruffed Grouse Society supporting management of a diverse mix of forest age classes, and one from a landowner supporting early successional forest management and browse/habitat for deer and grouse.

**General Comments:** During compartment review the SCA, MNFI and archeology database layers were available as each compartment was presented. Any occurrences were discussed and mitigated.

Spruce budworm risk analysis review: Add comments to all stands in the spreadsheet in the high and very high risk stands, or use soft factor 5T, to state why no prescription is needed at present.

- Stand 46 add clearcut with reserves. Leave retention patches.
- Stand 45 -add opening maintenance treatment.
- Stand 40 of Compartment 16 add clearcut with reserves. Leave retention patches.
- Stand 28 change comment: delete "stay out of patches of thick".

### C018 (Jeff Wise)

Discussion of comments from individuals: Discussion regarding Corned Beef Junction public comment and beech salvage. Discussed timber sale specs including: slash treatment, limited access points to harvesting, and limited skid trails. PRD stated that it is against safety rules to let trees/branches fall across the trails. Trails must be worked on twice per year to remove debris. Hazzard tree removal along the trail is important for safety.

Changes made at compartment review:

- Work with the public that has commented on treatments in this area to address their concerns.
- Add next steps for "monitor for invasive plant species" near Stand 63 gravel pit area.
- Stand 9: add a site condition to east for "too steep."

 Stand 9 west ½: Add treatment and site condition 5T – monitor spruce budworm.
