Comments from Stakeholders

The Open House at the Naubinway Field Office on September 17, 2019 had three people attend. An additional Open House at the Kinross Township Hall September 18, 2019 had two people attend. Attendees viewed maps and data, and discussed management prescriptions with staff.

One written comment was received from Bay Mills Indian Community. In C044 there was interest in planting conifers along Hutton Creek to improve water quality. Also, there was concern about sustainably managing cedar near roadways in C006 and other places to provide for cedar harvest permits for tribal members. These comments were discussed during the relevant compartments.

General Comments: During compartment review the SCA, MNFI and archeology database layers were shown as each compartment was presented. Any occurrences were discussed and mitigated.
