Compartment specific changes made during the Compartment Review

Compartment 14 – Stand Examiner Joshua Brinks

Stand 61 - Remove EO and buffer around the rare species. Remove an area in NE that has potential boreal forest and remove NW finger from treatment.

Stand 33 - Winter harvest for deer yard. Access will be restricted to wintertime due to rare species.

Stand 62 – Drop treatment.

Compartment 26 - Stand Examiner Kenny Fanelli

Stand 50 – Change wording to leave 2 White Pine per acre.

Compartment 40 – Stand Examiner Joshua Brinks

No changes at Compartment Review.

Compartment 41 – Stand Examiner Kenny Fanelli

Stand 45 – Changed treatment to Shelterwood. Cut all Aspen, leave 3-5 White Pine per acre, thin Oak where necessary for operability.

<u>Compartment 55 – Stand Examiner Kenny Fanelli</u>

Stands 31 & 35 – Remove treatments.

Stand 50 – Rewritten treatment so that they will cut ridges in the Western portion instead of cutting the entire stand towards the lakeshore to the East. Added several no-cut species to the list.

Stand 44 – Add to the invasive species control measures to include all options (mechanical, burning, etc.) for broader treatments and not just the spray. Add WLD Biologist, Dave Jentoft, to the Treatment Sponsor line.

Stand 65 – Remove Scotch Pine. Add oak and pine planting on portion of stand. Add site prep next steps to trench, spray, plant, and mechanical release work if needed.

Stand 58 – Change to Shelterwood harvest and let stand come back naturally. Only cut Red pine and no other species. Cut to 10-20 BA.
