# Compartment 39 (Stand Examiner – Pat Cotant)

No changes at Compartment Review. Wildlife staff were urged to discuss with the Grand Traverse Regional Land Conservancy the possibility of taking over ownership/management of the two inaccessible parcels located in T23N R14W, Sec. 15 & 10.

# Compartment 42 (Stand Examiner – Patrick Ruppen)

Stand 55 - Change the site condition to 3D: Recreation and scenic value.

David Lemmien proposes that Stand 131 be considered as excess State lands and dispose of it. T27N R10W, Sec.26, SW ¼ SW ¼ Triangular Section North of the powerline.

# Compartment 51 (Stand Examiner – Patrick Ruppen)

No changes at Compartment Review.

# <u>Compartment 60 (Stand Examiner – Craig Allen)</u>

Change the start date of treatments to Stands 125, 137, and 139, move treatments forward five years due to MSU research. Treatments will take place in YOE 2024.

#### <u>Compartment 61 (Stand Examiner – Tim Webb)</u>

Create an SCA surrounding and including Christmas Tree Lake. Look in to potential of adding this bog to the Lost Lake Bog ERA Plan if MNFI finds this bog has potential.

# Compartment 104 (Stand Examiner – Kelly Standerfer)

No changes at Compartment Review.

#### Compartment 128 (Stand Examiner – Paul Roell

No changes at Compartment Review.

### **Compartment 145 (Stand Examiner – Katie Armstrong)**

Stand 24 and 27 - Change treatment to "Natural Jack Pine" in the Objectives. Put in comments to leave the tops. Drop the next step treatment for trenching and add comment to the treatment to leave limb wood. Need follow-up treatment for scarification. The above changes can also be added to Compartment 135, Stand 70, which is also part of this management block for Kirtland's Warbler.

# **Compartment 151 (Stand Examiner – Kelly Standerfer)**

Stand 7 & 8 – Add monitoring treatments to the Red Pine replant harvests.

# <u>Compartment 158 (Stand Examiner – Tom Peterson)</u>

Stand 2 – Change the treatment to Overstory Removal, leave scattered mature White Oaks as a seed source.

Stand 16 – Change the treatment to Overstory Removal, leave scattered mature White Oaks as a seed source.

# <u>Compartment 161 (Stand Examiner – Paul Roell)</u>

Change management objective to Mixed Upland Deciduous.

# **Compartment 171 (Stand Examiner – Katie Armstrong)**

No changes at Compartment Review.

# <u>Compartment 221 (Stand Examiner – Steve Crigier)</u>

Add a final harvest treatment to stand 54 and replant to Red pine. Add the full spectrum of Red pine tools to next steps and delay the planting for 2 years and roller chop Jack pine regen before trenching. Delineate areas to propagate Oak regeneration. Add trail protection specs in this harvest.

#### **Compartment 266 (Stand Examiner – Steve Crigier)**

Stand 6 and 34 – Create regeneration pockets ranging from between 200 sq. feet to 1 acre in diameter. These gaps can be scattered around this stand in the best locations. Add a 3-year monitoring treatment post-harvest with follow-up treatments to address beech brush.

Stand 87 – Change Treatment from Shelterwood to Overstory Removal.

#### Compartment 48 YOE 2008

David Lemmien proposes that Stand 6 be considered as excess State lands and dispose of it. T27N R10W, Sec. 34, NE ¼ NE ¼ Triangular Section North of the powerline.

# <u>Compartment 11, 13 & 18 – Parcels to add to YOE 2019 (Stand Examiner – Tim Webb)</u>

Parcels were previously in Compartment 12 which has been dissolved. Compartment 12 would have been YOE 2019, so add these treatments to YOE 2019.

No changes at Compartment Review.

Plan approved at Compartment Review. Note from Bill Sterrett: "I still have maintenance concerns re: Who will be responsible for removing/controlling invasive species, ORVs, other threats to integrity of ERA."
