- A. Description of original monument and accessories and/or subsequent restoration:
- (G9) Corner common to Sections 21-22-27-28. 1958 - Remonumented by Billy D. Buckler RLS from two (probable) original B.T.s. Cedar, down, S43W 19 links, old blazes, no scribing; Y.Birch stump bottom N43E 3 links. Set 1" pipe with 4" brass cap. 5" Cedar S13E 33.5 links, 13" W.Pine N55W 80 links.
- (G11) Corner common to Sections 27-28-33-34. 1958 Billy D. Buckler RLS found and accepted a 2" dia. iron pipe with brass cap. Found no evidence of t 15" H.Maple East 78 links, 15" Y.Birch S24E 111 links. Found no evidence of the original corner. 13" H.Maple N45W 54 links,
- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
- (G9) The 1958 monument was not found. The remains of the original BTs were not recovered. Remonumented the 1958 position at record bearing and distance from the 1958 witnesses. The Cedar NBT SE, now 13" DBH, is in good condition, the 13" W. Pine NBT is now standing dead. Found the point of a wood post adjacent to the remonumented corner position. Accepted the 1958 position as a careful and faithful perpetuation of the position of the original corner.
- (G11) Found the 2" dia. pipe of record, with brass cap, no identifying marks, in good condition and at record bearing and distance from the remaining 1958 NBT H.Maple N45W, now 16" DBH, in good condition. Accepted the monument as the best available evidence of the position of the original corner.
