1910: J. W. McNeil set new stake in place of old stake w/large stone and earthen ware, no witnesses given.  
UNKNOWN: Alpena County Road Commission found 1/2" rerod in pav't, no witnesses given.  
1974: Feldhauser Assoc. (Edward LaCross, P.S.) found iron and witnessed.  
1979: R. S. Scott (D. B. Guthrie, P.S.) found 1/2" iron rod, and witnessed.  
1989: Earl T. Lewis, P.S. found 1/2" rod and recorded survey in Liber 2 of Surveys, page 743 and witnessed.  
1995: T. L. Fabis, P.S. found 1/2" iron rod and recorded survey in Liber 2 of Surveys, page 929, and witnessed.  
1997: Wilcox & Assoc. found 1/2" iron at intersection, no witnesses given.

### B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found 1/2" rerod 1' West of King Settlement Road C/L and 3' South of Smith Road.

This corner position is accepted as a careful and faithful perpetuation of the position of the original corner.
