A. Description of original monument and accessories and/or subsequent restoration:

(E8) Quarter corner common to Sections 20 and 21. 1981 - Remonumented by K.L.Sackett RLS at record bearing and distance from stump of probable original B.T. White Pine N71 1/2W 31 links which was mentioned in old Northern Paper Mills notes as being the original BT. Set 1"IDx36" I.pipe with 4" aluminum MDNR cap. 6" Balsam S82W 13.9', 5" Balsam N20E 9.8', 4" Balsam S22E 12.8'.

(F5) Quarter corner common to Sections 9 and 16. 1852 - Established by Deputy Surveyor Francis Houck S89 deg. 54'W 39.955 chains from Section corner 9-10-15-16. Set post. Fir 8 N44W 39 links, Sugar 14 S75E 18 links. Found no subsequent record.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(E8) Found the 1981 monument in good condition and at record bearing and distance from the 1981 NBT Balsam NE and Balsam SW, both in good condition with overgrown blazes. The NBT Balsam SE is dead and down. Accepted the monument as a careful and faithful perpetuation of the position of the original corner.

(F5) The original post and accessories were not recovered. Found a 1.5" ID iron pipe with Champion International Corp. location poster fixed to an adjacent 12" Sugar. The pipe is S89 deg. 39'28"W 2633.19' (39.897 ch.) from a pipe accepted by the undersigned as marking the position of Section corner G5. I accept the pipe as the best available evidence of the position of the original corner.
