(8-Sec. 9) Established the position for the corner midway and on a straight line between Quarter
corner 1316.31' west and the intersection of 1/4 lines of Section 9 1316.31' east.

(11-Sec. 9) Established the position for the corner at the intersection of straight lines connecting
opposite 1/16 corners.
