I, Stephan J. Szyszkoski, in a field survey on K4 06/13/2012 do hereby state  
that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2  
above were in conformance with regulations and rules therefore as required in the current manual of survey  
instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of  
a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with  
the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established,  
re-established, monumented, recovered, found as expressed below:

NOTE: Not more than 2 corners, all in the same town and range, may be recorded  
on this certificate.

A. Description of original monument and accessories and/or subsequent restoration:

(K4) Quarter corner common to Sections 11 and 12. 1975 - Reestablished by K.L.Sackett RLS midway and  
on the Section line between Section corners north and south. Set 1"IDx24" I.pipe with 4" alum. cap.  
10" Y.Birch N49E 30.3', 8" Sugar S40W 18.6', 14" Sugar S32E 20.7'.

(10-Sec. 12) South 1/16 corner between Sections 11 and 12. Not previously monumented.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(K4) Found the 1975 monument in good condition, substantially at the record position, and at record  
bearing and distance from the 1975 witnesses. The NBT Y.Birch N49E and Sugar S32E are both standing  
dead stubs. The NBT Sugar S40W is in good condition. Accepted the monument as a careful and  
faithful reestablishment of the position of the original corner.

(10-Sec. 12) Established the position for the corner midway and on the Section line between Section  
corner 1321.51' south and Quarter corner 1321.51' north.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(K4) Fd. 1"ID I.pipe w/4" alum. State of MI cap  
Set measuring nail with MDNR tag in the side of:  
12" Sugar S44W 19.0' old blazes 1975 NBT  
17" Sugar N41W 30.25' mrkd "1/4S NBT"  
4" Maple N46E 31.95' do  
5" Cherry S71E 11.75' do  
Set sq'd cedar post adjacent.  
Bearings are magnetic.

(10) Set 1"IDx32" I.pipe with 4" alum. MDNR cap  
made firm in a mound of rock.  
Set measuring nail with MDNR tag in the side of:  
11" Spruce N14E 14.4' mrkd "1/16S BT"  
4" Y.Birch S65E 22.8' do  
11" Maple S08E 23.15' do  
5" Hemlock S67W 32.85' do  
Set sq'd cedar post adjacent.  
Bearings are magnetic.
