A MONUMENT IS NOTED AT THE INTERSECTION OF THE SHORELINE TRAVERSE AND THE BASE LINE, "IRON ABOUT 18" BY 1/2" HAVE BEEN PLANTED AT ALL POINTS MARKED THUS 'o'....'

Description of corner evidence found and/or method applied in restoring or reestablishing corner:

SEARCHED FOR, DID NOT FIND IRON NEAR SHORE ALONG BASE LINE, AS INDICATED BY PLATS AND 1967 SURVEY BY WILKINS & WHEATON. HOWEVER, FOUND IRONS AT NORTHEAST CORNER AND NORTHWEST CORNER OF LOT 1 OF "NEW PLAT OF HICKORY POINT" AS SHOWN ON 1967 SURVEY. RESTORED CORNER BY BEARING AND DISTANCE FROM FOUND IRONS. MEASURED DISTANCES TO CORNERS EAST CONFIRMS STRONG'S CONTENTION THAT MEANDER CORNER IS LOST IN LAKE. SET REFERENCE MONUMENT TO MEANDER CORNER AT POINT THUS DETERMINED IN REFERENCE TO PLATS AND 1967 SURVEY. ACCEPTED THIS AS BEST METHOD OF RESTORATION OF PLATTED WITNESS CORNER TO LOST ORIGINAL MEANDER CORNER.
