Remon Concrete monument by single proportion to GLO between Remon. Corners at 'A9' and 'C9' per standard BLM procedure. Grid distance to 'A9' is 2319.23')2308.68' – GLO, 2310.66' – CPT) and to 'C9' is 2652.05' (2640' – GLO, 2641.65' – CPT, 2662.0' – TN). Benzie Co. Monument accepted as a careful and faithful re-establishment of the position of the original corner.
 - Reference Pt. 'A' N11°21°W 43.58' from 'B9' to Fd. 1" iron pipe per 1927 plat. This position by T. Norlin doesn't conform to any reasonable position and is not utilized as 'B9' in this survey.
 - Reference Pt. 'B' S0°11'E 19.23' from 'B9' to Fd. DNR Monument at Korr and Roser's position. This position was set by single proportion between 'C9' and a rejected position at 'A9'. DNR Monument not utilized as 'B9' in this survey. Remove DNR Monument and reset fd. 1/2" CIR that was found buried with the DNR Mon.

- B9 Stamped 3 1/2" Benzie Co. Remon. Brass Cap on 3/4" x 36" pipe encased in 4" x 36" concrete cylinder.
