A. Description of original monument and accessories and/or subsequent restoration:

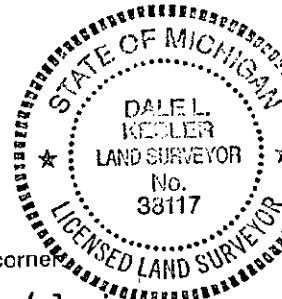
(M-2) 1827 - William Brookfield set post, accessories 14" White Oak S. 35-1/2° W. 100 Lks., 22" White Oak N. 78-1/3° W. 34 Lks.; Notes on file at Wightman-Peirce, Inc. office found stone 3' deep; 1983 H. D. Peirce & Associates found 8" plug, no witnesses.

(A-2) 1983 - H. D. Peirce & Associates found R.R. spike, no witnesses; R.W. Prestine found 3/4" iron bar in concrete, accessories nail electric pole N. 40° W. 26.4', Nail electric pole S. 40° E. 34.85', 16" Maple S. 24° W. 46.75', Manhole N. 45° E. 8.05'.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(M-2) Found stone 4.0 feet deep. Accepted stone as best evidence of corner.

(A-2) Nothing was found. Set corner 95.04' south of the east quarter corner of Section 1, T 6 S, R 16 W and on line between the east quarter corner Section 1, T 6 S, R 16 W and the southeast corner of Section 1, T 6 S, R 16 W.



C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(M-2) Set standard 2' iron pipe w/aluminum cap and accepted as a careful & faithful perpetuation of the position of the original corner.

Standard 2' iron pipe w/alum cap S. 95.04'
Set nail w/witness tag in power pole N. 21° 09' E. 60.67'
Set nail w/witness tag in 30" Maple S. 36° 01' E. 60.03'
Set nail w/witness tag in 38" Maple S. 35° 19' W. 66.33'
Found 1" iron pipe - S. 87° 22' W. 33.06'

(A-2) Set standard 2' iron pipe w/aluminum cap. This position not established by original Gov. surveyors. This monument is accepted as the best available evidence of the position of the corner.

Top bolt fire hydrant S. 56° 08' E. 23.10'
Set PK nail in 24" Maple N. 37° 31' E. 55.21'
Set PK nail in 36" Oak N. 43° 04' W. 57.07'
Set PK nail in power pole S. 86° 11' W. 41.28'
