Szyszkoski ..., in a field survey on DB January 27, 1992 do hereby certify that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, re-monumented, recovered, found as expressed below

A. Description of original monument and accessories and/or subsequent restoration:

(DB) Corner not established in original survey. Found no subsequent record.

(C9) Corner previously recorded by Ostling (LCRC rec. L.1 P. 79, Chippewa County records) as Ed. 2° pipe in 1973.

(D9) Corner established by John Mullett, 1845. Accessories: Sugar 10 55W 10, Fir 8 NIBW 20. Found no subsequent record.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner.

(DB) Found no monumentation at this position. Established corner at the intersection of straight lines commecting opposite 1/4

(CP) Found and accepted 2° pipe. Ostling's 3 accessories check. This corner is being recorded to document additional accessories.

(D9) Original post and accessories not recovered. No monumentation found at corner location. From the pattern of cultural improvements along the south line of section 20, and the discrepancy in the distance with GLO between the SE corner and SM corner of the section (5400°M, 5293°R), I conclude that the original corner was placed on a random line east from the SW corner and not midway on the corrected line between section corners as stated in the original notes. There is evidence that this situation also exists in relation to the south 1/4 corner of section 29, T43N-R2E. The improvements noted above are: location of the county road along the south line of the section with a pronounced angle point at the corner location, remains of an old E-W fenceline south of and parallel to the road, and the remains of an old N-S wire fence south of the corner location. I reestablished the corner in the road surface and at record distance east from the SN corner of section 20 as recorded this date. My measure east and west to adjacent corners is 2753.53° and 2646.6° respectively.
