A. Description of original monument and accessories and/or subsequent restoration:

A-2 (T45N, R1E)

1/4 Corner Common to Section 6, T45N, R1E & Section 1, T45N, R1W

Corner recorded by Neil E. Hill, P.S. 27447, in liber 7, page 30, of Chippewa County corner records (5-21-1987) as a iron with cap 27447 in a monument box with the following ties:

End Fence Post, East 75.85'

Fence Post, N60°E 87.09'

Mailbox Post, S75°W 21.89'

Top Center of Steel Post behind

Telephone Pedestal, S65°W 63.02'

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

A-2 (T45N, R1E)

This corner is being perpetuated as part of the Chippewa County Remonumentation Program.

Found iron with cap 27447 in a monument box in centerline of Highway M-129.

Steel post behind telephone pedestal is the only witness from 1987 records

that is still intact. Fence posts have fallen down and mailbox post is gone.

Accepted corner as found and established three new witness objects.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

A-2 (T45N, R1E)

Corner is a iron with cap 27447 in a monument box in the centerline of Highway M-129. Witnesses:

Power Pole (DR2-96-1), N19°E 236.36'

Power Pole (DR2-97), S38°E 121.93'

Highway Dept. R.O.W. Marker iron in Monument Box, North 225.32'

Center of Steel Post behind

Telephone Splice Box, S70°W 62.91'

Note: Measurements to poles are to a nail and tag in the side.

Bearings are compass bearings corrected for declination.
