

A. Description of original monument and accessories and/or subsequent restoration:

(M-11/12) Meander Corner on East Line of Section 36, Township 48 North, Range 1 East.

The original corner was placed in 1845 by John Mullett 11.00 chains North of 1/4 post. Found no reference to corner in County Surveyor notes. In 1992, William L. Karr, P.S. 27450, set witness comer to Meander Comer 45 feet South of shore of St. Mary's River on the extension of PEWA COL the Range Line to South. Corner falls 65.06 feet North of record G.L.O. position. Karr filed a L.C.R.C. in Liber 9, Page 1270 the County Corner Records.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

E VUMEN (M-11/12) Meander Corner on East Line of Section 36, Township 48 North, Range 1 East.

This corner is being perpetuated as part of the Chippewa County Remonumentation Program.

Found 1/2" iron pin with stamped aluminum cap as recorded by Karr. Corner position was accepted as a Witness Corner William Weander Corner because distance South to 1/4 Corner is 65 feet longer than record G.L.O.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner: (M-11/12) Witness Corner to the Meander Corner on East Line of Section 36, Township 48 North, Range 1 East. Corner is a 1/2" x 48" iron pin with 2" stamped aluminum cap approximately 45 feet South of water's edge of St. Mary's River.
