1967- Gregory A. Shadko set a DNR monument
19__ Nick Deyoung used the corner in surveys around the Nowland Lake area.

MC- M8/M9 Meander corner common to Sec. 24, T.33N., R.8W. & Sec. 19, T.33N., R.7W.

1999- Found the DNR monument by Shadko and witnesses of record. Set a Charlevoix County Monument at GLO distance
From M-9 to the South.
