- A-1 [NW COR S.6] JAMES H. MULLETTE, D.S. - 1848 - WOOD POST (BIRCH 15°-N35°W-35 LINKS) (BIRCH 14°-S60°W-35 LINKS)
M.S. McNABB - 1918 - IDENTIFIED FROM ORIGINAL NW BIRCH BT - SET NEW STAKE (CEDAR STUMP 20°-S70°E-15.0')
M.S. McNABB - 1920 - FROM PREVIOUS SURVEY - (CORNER FENCE POST-WEST-20.9') (FENCE POST-EAST 25')
- A-2 [W1/4 COR S.6] JAMES H. MULLETTE, D.S. - 1848 - WOOD POST (LYNN 14°-S71°W-09 LINKS) (LYNN 24°-N41°W-14 LINKS)
M.S. McNABB - 1920 - IRON BOLT IN PLACE (CORNER FENCE POST-WEST-17') (FENCE POST-EAST-28')

- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

A-1 [NW COR S.6] FOUND IN PLACE McNABB'S 1920 IRON PIPE, 24" M/L BELOW EXISTING ROAD SURFACE.
IDENTIFIED CORNER POSITION BY EXISTING E-W OCCUPATION & N-S COUNTY ROAD IMPROVEMENTS AND
COMPARISON OF McNABB'S MEASUREMENTS TO ADJOINING CORNERS. ACCEPTED EXISTING MONUMENT AS
BEING A CAREFUL & FAITHFUL PERPETUATION OF THE POSITION OF THE ORIGINAL CORNER.

A-2 [W1/4 COR S.6] FOUND IN PLACE AN IRON BOLT AS MENTIONED IN THE 1920 SURVEY RECORDS OF M.S.
McNABB. HIS ACCESSORIES TO THE CORNER WERE APPARENTLY REMOVED IN COUNTY ROAD IMPROVEMENTS.
IDENTIFIED CORNER POSITION BY EXISTING OCCUPATION TO THE WEST & N-S COUNTY ROAD IMPROVE-
MENTS AND COMPARISON OF McNABB'S MEASUREMENTS TO ADJOINING CORNERS. ACCEPTED EXISTING MONU-
MENT AS BEING A CAREFUL & FAITHFUL REESTABLISHMENT OF THE POSITION OF THE ORIGINAL CORNER.

RED PINE 8" W. BIRCH 7" CHISELED "X" ON LARGE FIELD STONE SURVEY MONUMENT SIGN POST
N32°E S65°E S42°E WEST
50.20' 36.80' 34.70' 21.67' (TO FACE)

A-2 SET OVER EXISTING MON & 6" M/L BELOW RD SURFACE A 5/8" X 18" REBAR W/A 3-1/4" ALUMN CAP STAMPED TO ID THE CORNER POSITION.
MAPLE 14" POWER POLE SURVEY MONUMENT SIGN POST NOTE: OPEN FARM FIELD IN THE NW & SW QUADS
N59°E S24°E WEST NO OTHER WIT'S AVAILABLE.
53.70' 54.32' (TO FACE) 19.68' (TO FACE)
