F-3 [N1/4 COR SEC 9] A.MERRYWEATHER, DS-1848-SET WOOD POST-(BIRCH 06" N42°W 15 LINKS)(BIRCH 06" S21°E 22 LINKS)  
NO RECORD EVIDENCE OF CORNER RECOVERY AND/OR SUBSEQUENT MONUMENTATION

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

F-1 [N1/4 COR SEC. 4] NO CORNER EVIDENCE FOUND. REESTABLISHED CORNER POSITION AT BASE OF LARGE  
CORNER FENCE POST (DOWN) AT JCT OF ANCIENT FENCE LINES (N & W) WHICH ARE DOWN AND IN POOR  
REPAIR. AS THE CORNER POST FOUND IS SIMILAR IN SIZE & NATURE TO OTHERS FOUND THROUGHOUT THIS  
FARMLAND AREA WHERE CORNER MONUMENTATION WAS FOUND TO EXIST I HAVE ACCEPTED THIS POSITION TO  
BE THE BEST AVAILABLE EVIDENCE AS TO THE LOCATION OF THE POSITION OF THE ORIGINAL CORNER.

F-3 [N1/4 COR SEC 9] FOUND IN PLACE AND BADLY BENT A 1 1/4" X 42" IRON BAR. ID CORNER MONUMENT  
FROM E-W COUNTY RD IMPROVEMENTS AND ANCIENT FARM FENCES NORTH AND SOUTH. ACCEPTED EXISTING  
MONUMENT AS BEING THE BEST AVAILABLE EVIDENCE AS TO THE LOCATION OF THE POSITION OF THE  
ORIGINAL CORNER. DUE TO POOR CONDITION OF THE EXISTING MONUMENT, THE LOWER 18" WAS CUT OFF  
AND DRIVEN TO REFUSAL.
