B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

F-9 [N1/4 COR SEC 28] NO CORNER EVIDENCE FOUND. IDENTIFIED THE WEST LINE OF THE ASSESSOR'S PLAT NO.1 CITY OF GLADSTONE (LIBER "B" OF PLATS PAGE 51) AND EXTENDED IT NORTH THE PLAT DISTANCE & ESTABLISHED THE W1/16 COR ON THE N. LINE OF SEC 23. EXTENDED LINE EAST FROM NW COR SEC 28 THRU THE W1/16 AND ESTABLISHED THE 1/4 COR ON THIS LINE AT A PROPORTIONATE DISTANCE EAST OF THE W1/16 CORNER.

F/G-9 [M.C.-REFERENCE MONUMENT] FOUND IN PLACE A 3/4" IRON PIPE MONUMENT AT THE INTERSECTION OF THE NORTH LINE OF SEC 28 AND THE NORTH LINE OF THE PLAT OF SOUTH SHORE ADDITION (LIBER "A" OF PLATS ON PAGE 24) 30' SWLY FROM THE NELY CORNER OF LOT 7 OF BLK 2 OF SAID PLAT. EXTENDED A LINE EAST FROM THE N1/4 COR OF SEC 28 THRU THE PLAT MONUMENT & ESTABLISHED THE M.C. AT THE "GLO" DISTANCE WEST OF THE NORTH 1/4 COR, WHICH FALLS IN THE ASPHALT SURFACE OF 10TH ST. SET THE REFERENCE MONUMENT ON LINE 20.34' WEST OF THE M.C. POSITION.
