## B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

I-1 [NW COR S.2] FOUND IN PLACE A 1" I.P. W/A SURVEY CAP SET INSIDE A MON BOX. THIS CORNER WAS ESTABLISHED BY MYSELF IN 1978 AND REC'D IN LIBER 2 OF LCR'S ON PAGE 478. THIS CORNER WAS RESET FROM THE RETRACEMENT OF McNABB'S 1934 SURVEY OF THE LINE COMMON TO SEC'S 34/35 T40N R24W. THIS POSITION MATCHES WITH EXISTING LINES OF OCCUPATION & PRESENT COUNTY ROAD IMPROVEMENTS AS WAS FOUND TO EXIST IN 1978. ACCEPTED THIS POSITION AS BEING THE BEST AVAILABLE EVIDENCE AS TO THE LOCATION OF THE POSITION OF THE ORIGINAL CORNER. ALL ACCESSORIES ESTABLISHED IN 1978 HAVE BEEN REMOVED.

I-2 [W1/4 COR S.2] CORNER MONUMENT AS ESTABLISHED IN 1978 BY MYSELF HAS BEEN DESTROYED BY RECENT ROAD IMPROVEMENTS. RESTORED SAME FROM RETRACEMENT OF PRIVATE SURVEYS PERFORMED PRIOR TO THE DESTRUCTION OF THE CORNER MONUMENT.

## C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

I-1 REPLACED I.P. W/A 5/8" X 18" REBAR W/A 3-1/4" ALUMN CAP STAMPED TO ID THE CORNER POSITION.
