I, Richard E. Oelke, in a field survey on 10 December, 19 99 do hereby certify that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, re-monumented, recovered, found as expressed below:

**NOTE:** Not more than 4 corners, all in the same town and range, may be recorded on this certificate.

A. Description of original monument and accessories and/or subsequent restoration:

**Abstract:** GLO set corner in 1840's. Trowbridge found 1/2" rod in 1983. This point has been used in subsequent surveys by local surveyors.

See back page for chronological history of corner.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

**Found:** 1/2" iron rod, 2' long, set by persons unknown. This point falls +/-6' N of centerline of Division Road and +/-6' E of the centerline of a dirt two track to the south. Fits old fence to the North, +/- 39' S of old N right-of-way fence. Falls in a road cut area.

- 3) N 31° E, 37.21', 5" aspen, tagged w/ a yellow cap in N face
- 6) N 51° E, 55.35', 3" aspen, tagged 33984 in SE face
- 2) S42° W, 51.95 pp, tagged 15410 in NW face
- 4) N 05° W, 33.46', 8" aspen, tagged w/ a yellow cap in SW face

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

**Set:** The 1/2" rod noted above was removed, and replaced with a 2" diameter, 30" long, PVC pipe with a base magnet and a standard brass Emmet County Survey Remonumentation Program Cap. This position is accepted as a careful and faithful perpetuation of the position of the original corner.
