No GLO evidence was found. Found DNR aluminum cap on 1" X 8' long pipe with the top 3.5' bent, in river 3'± West of East bank of river. Found Roser & Lapham accessories fitting position of the straight portion of pipe. Accepted the position found bent DNR monument as the best available evidence of the position of the original corner and replaced it with 4" DNR aluminum cap on 1" X 57" galvanized iron pipe with mound of boulders and stones around pipe. DNR Cap is in 4" of water and 4" above the water surface.
