- a.) Corner common to Sections 5-6 T51N-R36W and Sections 31-32 T52N-R36W. 1963 Billy D. Buckler RLS found and accepted a 1"ID iron pipe which he describes as having been set by Copper Range Company. No original evidence found. 11" Hard Maple S12°W 34 links, 9" B.Cherry S42°E 50 links, 21" Hard Maple N49°W 18 links.
- b.) Quarter corner common to Sections 5 and 6. 1985 K.L.Sackett RLS reestablished the corner position proportionate to the original record between Section corners north (39.00 ch. R) and south (40.00 ch. R). Set 1"IDx32" I.pipe with 4" aluminum cap. 7" Sugar S52°E 23.4', 8" Sugar N34°E 28.4', 7" Sugar S09°E 41.2'.

Part B: Surveyor's Report on Perpetuation, Restoration, Reestablishment, or Monumentation of Corner

- a.) The 1963 monument was not recovered. Remonumented the 1963 position at record bearing and distance from the 1963 witnesses. Both Sugars are in good condition, the B.Cherry is a rotted stump.
- b.) The 1985 monument was not recovered and has likely been destroyed by heavy equipment working the adjacent power line. Reestablished the 1985 position at record distance and at substantial record bearing from the 1985 witnesses Sugar S52°E and Sugar N34°E, both in good condition with markings visible. The position thus established is substantially at the record position, being 0.8' south and 0.9' east of the proportionate position noted in the 1985 record and is accepted as a careful and faithful reestablishment of the position of the original corner.
