(8-Sec. 20) Established the position for the corner midway and on a straight line between Quarter corner 1382.27' west and the Center of Sec. 20 1382.27' east. The Center of Section 20 is the intersection of 1/4 lines, the N-S 1/4 line being run from the North 1/4 corner of record at a bearing which is the weighted mean bearing of the east and west Section lines.

(3-Sec. 20) Established the position for the corner midway and on the Section line between Section corner 1317.54' north and Quarter corner 1317.54' south. The position for the corner falls approximately 15' south of the edge of a stream (2 feet of snow on the ground at this time).
