Geo. Mark: Survey #930, May 30, 1882, stone; Survey #1016, Mar. 11, 1886, stone with brick.

Robert E. Burris, Sr., June 5, 1973: LCRC L. 1 - P. 303, #2518, set R.R. Spike (See LCRC).

Keyno J. Shellenbarger: Survey recorded Feb. 12, 1992, Liber 649, Page 23, #67926

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found R.R. spike at road surface. All of the references in above LCRC remain.

Dug at position of R.R. spike. Nothing else found.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Replaced R.R. spike with 3/4" x 30" iron with remonumentation cap in monument box and is accepted as the best available evidence of the position of the original corner.
