B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

FOUND THE BOAT SPIKE AS RECORDED BY DYER & (1) REMAINING BEARING TREE WITH P.K. NAIL, AT INTERSECTION OF DIETZ & ROWLEY ROADS. EXCAVATED A 4' DIA. HOLE AT TOP DOWN ± 3 FEET TO 6" BELOW OLD CLAY ROAD BED TO A 6' DIAMETER HOLE. FOUND HORIZONTAL R.R. SPIKE AT 2' BELOW ROAD SURFACE ± 6" WEST OF BOAT SPIKE AT 3' DEEP AND 1' ± SW'LY OF SPIKE FOUND BROKEN HORIZONTAL BLUE STONE AND A FEW VERY SMALL PIECES OF BRICK. THIS WAS THE ONLY STONE I BELIEVE THE STONE WAS VERY POSSIBLY THE SAME FOUND IN THE EXCAVATION. AS CITED BY T.J. BROWN. COULD NOT DETERMINE ITS ORIGINAL POSITION AND ACCEPTED THE POSITION OF THE BOAT SPIKE AS FAITHFUL PERPETUATION OF THE CORNER BECAUSE OF THE CLOSE PROXIMITY OF THE STONE.
