Szyszkoski , in a field survey on 12/17/15 that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey 5 instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of <sup>6</sup> a Court of Law and for that the corner points mentioned in lines 3, 4 and 5 above were in conformance with 7the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, a re-established, monumented, recovered, found as expressed below:

A. Description of original monument and accessories and/or subsequent restoration:

(8-Sec. 19) Center-West 1/16 corner, Section 19. Found no record of prior monumentation.

(4-Sec. 19) Northwest 1/16 corner, Section 19. Found no record of prior monumentation.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(8-Sec. 19) Established the position for the corner 20 chains, proportionate to the original record west of the intersection of 1/4 lines of Sec. 19 and on a straight line between said intersection 1320.04' (20.00 ch. US) east and Quarter corner A8 1329.62' (20.145ch. US) west.

(4-Sec. 19) Established the position for the corner at the intersection of straight lines connecting opposite 1/16 corners. 1/16 corners #1, #3, and #8 are monumented. 1/16 corner #5 is not monumented. I found a 1"ID I.pipe S32°W 12.65' from the position used for #5. The pipe was not accepted for controlling the subdivision of the NW1/4 of this section. The position used for #5 is midway and on a straight line between monumented B7 and the unmonumented intersection of 1/4 lines. From the monumented #4, I found a 1"ID I.pipe S31°W 7.12' distant, not accepted. I conclude that whoever set this pipe ran in the W1/16 line incorrectly, without regard to the fractional nature of the west 1/2 of this section, using positions for 1/16 corners #1 and #8 midway between controlling corners, rather than establishing them proportionate to the US plat dimensions.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:
