A. Description of original monument and accessories and/or subsequent restoration:

Original corner established by Austin Burt, U.S. Deputy Surveyor, in 1847.

Original witnesses: Lynn 14" S 20° E 8 links
 Sugar Maple 12" N 12° W 37 links

Donald D. Lappala RLS restored corner position on 22 September 1964 by marking a cross (x) in pavement using a 1934 Michigan State Highway project plan and existing reference monuments. He also set a 2' x 5' concrete filled iron pipe w/ bronze tablet as a reference monument (Liber 3, Page 283).

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found iron bar in monument box set by unknown surveyor.

Found witness recorded by Lappala as: 9" Sugar Maple S 44° W 75.5' (114.4 links)

Found witness used by unknown surveyor: 7" Maple S 28° E 74.64'

Lappala reference monument destroyed.

Corner record research on file with county representative.
