1852, Resurvey, by George H. Cannon, closed from the East; Spruce Pine 10", N58°E, 97 Lks; Spruce Pine 10", S64°E, 43 Lks
1940's. Surv. by M. Schaaf, set 2" pipe in concrete in centerline of E-W road; Pine 10", S52°E, 50 Lks; Pine 18", N55.5°E, 13 Lks

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

M-9: Sec. 30r. Common to Secs. 24 & 25, T25N-R5W, Garfield Township; A-9: Secs. 19 & 30, T25N-R4W, Beaver Creek Township, Crawford Co.

Found 3/4" pipe with RLS cap in East-West Road, 2' East of centerline trail to South and 30' West of centerline trail to the North, believed to be the perpendicular of Schaaf's corner.

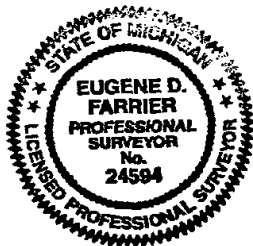
No G.L.O. witnesses were found.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

M-9: Sec. Cor. Common to Secs. 24 & 25, T25N-R5W, Garfield Township: A-9: Secs. 19 & 30, T25N-R4W, Beaver Creek Township, Crawford Co.

Found 3/4" pipe with RLS cap in East-West Road, 2' East of centerline trail to South and 30' West of centerline trail to the North, believed to be the permeation of Schaaf's corner. Added 5/8" iron with brass cap in mon. box

Kankaska County Pear Group accepted the above monument as the best available evidence of the position of the original corner.
