A. Description of original monument and accessories and/or subsequent restoration:

H7 – 1852 – GLO – Cannon – Set qr. Sec. post, 1) W Pine 16" N52°W 60, 2) W Pine 14" S39°E 83

- 1957 - DNR corner record – B. D. Buckler, PS #8887 – This corner was found by forestry division survey crew while making a partial resurvey of this township. Found ½" iron bar in place, presumably by G. F. DeLaMater, with sites for both government BT's accepted as ¼ corner, having no evidence to the contrary. - 1" pipe with 4" brass cap set at ½" iron bar, 3) 7" B. Oak N41°E 83 L., 4) 5" B. Oak S62°E 34½ L., 5) 12" B. Oak S18°W 108 L.

- 1978 – Consumer's Power Co. Survey drawing #S-F17406 – DAA – Found 1" pipe with 4" brass cap, 3) 7" B. Oak N41°E 83 L., 4) 5" B. Oak S62°E 34½ L., 5) 12" B. Oak S18°W 108 L.

B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:

H7 – ¼ Corner common to sections 15 & 22, T26N, R5W – Found 4" Department of Conservation Brass Cap Monument on 1" iron pipe. Found witnesses #3, & #4, and stump remains of witness #5. 4" DOC Monument accepted as a careful and faithful perpetuation of the position of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

H7 – 4" DOC Brass Cap on 1" galv. iron pipe. Set Blue carsonite Post 1' North.

North 27.08' to found nail in W side 10" R. Pine
S59°E 22.60' to found nail in SW side 12" Oak (#4)
S48°W 17.63' to found nail in SE side 10" R. Pine
N88°W 19.32' to found nail in N side 11" R. Pine
