- <u>19</u> 1852 G. Cannon set post cor. 22-23-26-27
 - 1) W. Pine 18" S22°W 10
 - 2) Beech 6" N58°E 22
 - 1952 DNR Corner Record D.C. DeLaMater, PS #5778 This corner was established, by double proportionate measurement, by Forestry Division survey crew, while making a partial resurvey of this Township. Set 1" pipe with 4" Brass Cap
 - 3) 14" W. Oak S43°E 26 L.
 - 4) 14" W. Oak S46°W 167 L.
- B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:
- 19 Section Corner common to Sections 22, 23, 26 & 27, T26N, R6W Found 1" iron pipe with a bent top and witnesses #3, #4 fitting position per the 1952 DeLaMater corner record. Dug out pipe and placed at undisturbed position a 4" DNR aluminum Cap on 1" X 36" galvanized iron pipe. Position of found 1" I.D. iron pipe accepted as a careful and faithful reestablishment of the position of the original corner.
- C. Description of monument for corner and accessories established to perpetuate locating the position of the
