E-7 cor. common to Sec. 16, 17 20 & 21, T27N-R7W  
Found and accepted axel shaft in C/L Court St (M-66) & 10' South of C/L Hyde St. GLO witnesses fell in road cut. Pulled axel shaft & reset w/ 5/8"x36" re-rod w/ Brass Cap, 0.6' below bit.  
On 12-16-93 the Kalkaska Co. peer group approved the above monument as a careful and faithful reestablishment of the position of the original corner.
