E-8 cor. common to Sec. 20 & 21, T27N-R7W  
Found boat spike in Mon. Box 0.8' E. of C/L M-66, w/ accessories. GLO witnesses fell in road fill.  
On 12-16-93 the Kalkaska Co. peer group approved the above monument as a careful and faithful reestablishment of the position of the original corner.
