

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

E-11 Found standard Kent County Monument 2.5' South of the C/L of 100th Street running E-W and on the C/L of Ivanrest Avenue running N-S per L.C.R.C.'s #1636 and #4617 as set by Nederveld & Jonker in place of a 1" square iron they found which checked L.C.R.C. #212.


