A. Description of original monument and accessories and/or subsequent restoration:

(11-Sec. 28) Southwest 1/16 corner, Section 28. Not previously monumented.

(10-Sec. 28) South 1/16 corner between Sections 28 and 29. Not previously monumented.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(11-Sec. 28) Established the position for the corner at the intersection of straight lines
connecting opposite 1/16 corners.

(10-Sec. 28) Established the position for the corner midway and on the Section line between Section
corner 1308.78' south and Quarter corner 1308.78' north.
