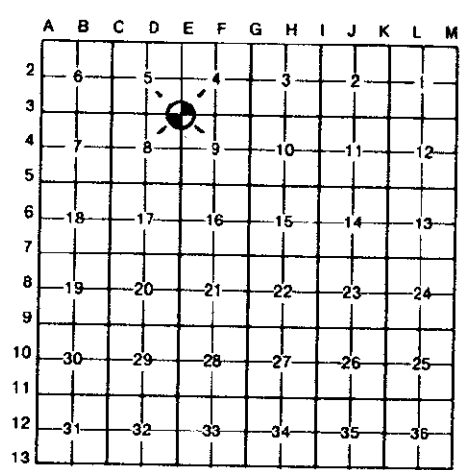

A. Description of original monument and accessories and/or subsequent restoration:

1826: United States Government Survey; Set Post, Corner to Sections 4, 5, 8 and 9.

Wh. Oak 5" South 56° West 126 Lks
Y. Oak 18" North 73° East 250 Lks

1883: F. Hodgman, County Surveyor; Ran South 58 3/4° West, 80 Lks from stump of Y. Oak bearing
tree by Pratt, to stake. Bored 3'. Put in brick and stone in bottom and 2' earthen
post over.

Red Oak 18" North 10° East 148 Lks
Wh. Oak 12" South 82 1/2° East 104 1/2 Lks

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

1941: Wilkins & Wheaton Engineering Company; Found tile 1' below surface. Placed iron over.

Oak 24" North 70° West 91.45'
Maple 6" North 20° West 105.69'
Hickory 8" North 20° East 114.15'
Oak 24" North 80° East 192.68'

1994: Found 1/2" iron in monument box, tile 1' below in Centerline of 40th Street.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

E-3 Southwest Corner Section 4, T. 1 S., R. 9 W., ratified by the Kalamazoo County Remonumenta-
tion Program Peer Group on December 15, 1994. Found a 3" round tile with "X" on top, 20"
below surface, as called for in 1883 remonumentation survey by F. Hodgman and is accepted
as a careful and faithful perpetuation of the position of the original corner. Placed 20"
Harrison monument and monument box over tile.

Exist. Nail/Tab in North Side 30" Oak South 70° West 116.61'
