Kester , in a field survey on _ do hereby certify that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, re-monumented, recovered, found as expressed below:

NOTE: Not more than 4 corners, all in the same town and range, may be recorded on this certificate.

A. Description of original monument and accessories and/or subsequent restoration: Corner Post established by U S Government Deputy Surveyor Robert Clark, 1826, Accessories: Beech 7 S17W 7, Beech 12 N63E 17.

Remonumentation by F. Hodgeman, 1883, Found Stone, Charcoal and old Stake bottom with side Stones 50 Lks East & West and Stump of one witness of resurvey N E, all agreeing together. Bored 3' and put in 3' Earthen Posts with Stone around. Accessories: Elm 6" N75 E 47 Lks, Elm 9" S51 3/4E 42 Lks.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner: Original Corner and Accessories not recovered. Found Stone above Solid Clay Tile with X on top 4.5' below road surface as called for in 1883 Remonumentation by F. Hodgeman.
