I, Robert E. Snell, in a field survey on May 20, 19 94,

do hereby certify that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, re-monumented, recovered, found as expressed below:

A. Description of original monument and accessories and/or subsequent restoration:

1825: U.S. Government Survey; Set 1/4 Section Post, in prairie and raised mound.  
The indian village of "Prairie Ronde" bears from this point North 84° West,  
distance about 2 1/2 miles.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

1994: Dug and found nothing except a previously dug hole. Placed a 20" Harrison monument for East 1/4 Post Section 12, T. 4 S., R. 12 W. (M-4) on line between Southeast Corner Section 12, T. 4 S., R. 12 W. (M-5) and West 1/4 Post Section 7, T. 4 S., R. 11 W. (A-5), 20.13 feet (1/2 Government jog) South of West 1/4 Post Section 7.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

M-4 East 1/4 Post Section 12, T. 4 S., R. 12 W., Ratified by the Kalamazoo County Remonumentation Program Peer Group on September 15, 1994. Placed a 20" Harrison monument at the corner as described in "B" above, and is accepted as a careful and faithful reestablishment of the position of the original corner.
