

I, Craig W. - A. Description of original monument and accessories and/or subsequent restoration:
- E11 1838 GLO S. Sibley Set Post
 - 1) Pine 8" N73°E 91 L. 2) Pine 8" S29°W 72 L.

 - 3) 8" W. Oak N15°E 2.8';

- B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:
- E11 Section Comer common to Sections 28, 29, 32 & 33 Fd. 4" Dept. of Conservation (DOC) Aluminum Cap on 1" iron pipe per Roser. No GLO evidence found. Monument falls on narrow NW-SE Sand ridge. Measured North 70'± to edge of Leather leaf marsh; East 64'± to Edge of Leather leaf marsh; South 39'± 10' to Edge leather leaf marsh and West 36'± to edge of Leather leaf marsh. These marsh calls are not noted in the GLO notes. DOC Monument accepted as a careful and faithful reestablishment of the position of the original corner.
