Description of original monument and accessories and/or subsequent restoration:

GLO 1819 Joseph Wampler set post corner Sec.'s 1 & 12 Hickory 9 N 68 W 10 Lynn 8 S 8 E 20 1873 Webb Jipson surveyed section 12 and called for Brick & Stone

Early 1900's J.L. Richard records call for Brick & Stone

1925± Horton Rd. was surveyed and the notes call for ending at the NE corner of Section 12 but type of monumentation is not given.

1928 Thompson Hwy, was surveyed by Harold Clegg RLS 13578 and notes show he found gas pipe 1969 I dug at a location using J.L. Richard's record distance from a occupied line to the north and a occupied line to the west using a distance from W. Jipson's survey of Section 12. This location is about 13' south of the boat spike I had set using the witnesses given in the Horton Road survey from a Pear tree and a Pine tree. 1973 I found the boat spike & replaced it with an iron pipe and recorded it for M-3 T8S R4E in L 2, P 495 1980± Lenawee Co. Road Commission rebuilt the road and set a monument box at the iron pipe

Description of corner evidence found and/or method applied in restoring or reestablishing corner:

April 7, 1998 I found 3/4" X 2' iron pipe in monument box and replaced it with a 5/8" X 3' re-rod with Lenawee Co. Re-mon cap stamped P.S. 13040

Description of monument for corner and accessories established to perpetuate locating the position of the corner:

5/8" X 3' re-rod with Len. Co. Re-mon cap stamped P.S. 13040 in monument box and is accepted as the best available evidence of the position of the original corner.
