A. Description of original monument and accessories and/or subsequent restoration:

(B5) Quarter corner common to Sections 7-18. 1853 - Established by G.H.Cannon Deputy Surveyor during a correctional survey of this township, S89 deg. 12' E 39.66 chains from Section corner A5 and West 40.31 chains from Section corner C5. Beech 10" S54 1/2 W 25.5 links, Y.Birch -- N5E 33.5 links. 1974 - Remonumented by Billy D. Buckler RLS: "Cor. set at wood post setting at SW corner of spruce plantation. Re-established midway and on line bet. two section corners". NBT 4" W.Pine S5W 16.3'.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(B5) The original post and accessories were not recovered. Found the 1974 monument in good condition and at record bearing and distance from the W.Pine NBT, now 12" DBH in good condition. Mr. Buckler's statement that this corner was reestablished midway and on line between two section corners is not correct, does not seem to apply to this corner, and its appearance in the record is taken to be the result of a clerical error. The monument was recovered N89 deg. 57'19"E 2608.28' from Section corner A5 and S89 deg. 47'44"W 2654.75' from Section corner C5 (true bearings), very near to the original record distances, proportionate. I accept the monument as the best available evidence of the position of the original corner.
