

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner: (B-1) 1/4 Corner common to Section 6 Township 45 North, Range 12 West and Section 31 Township 46 Worth 12 West.

This corner is being re-established as part of the Luce County Remonumentation Program.

Found no evidence of the original corner or subsequent restoration. Re-established the corner by single proportionate measurement using 1/4 corner 3/34, 3 miles to the East and the Township Corner 1/2 mile to the West. Distance East is 15,823.68 feet (GLO - 15,840), distance West is 2518.60 feet (GLO - 2521.2 feet).

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner: (B-1) 1/4 Corner common to Section 6 Township 45 North, Range 12 West and Section 31 Township 46 North, Range
