

This corner is being re-established as part of the Luce County Remonumentation Program.

Re-established the corner by single proportionate measurement using 1/4 corner 3/34, 1/2 mile to the East and the Township corner 3 miles to the West. Distance East is 2637.28 feet (GLO – 2640.00). Distance West is 15,705.00 feet (GLO – 15,721.20 feet).

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner: (G-1) Section Corner common to Sections 3 and 4 Township 45 North, Range 12 West and Sections 33 and 34 Township 46 North, Range 12 West.
