Found no evidence of original government corner. Found "T" iron in centerline of Dean Road in line with old fence remains to the North and a field line to the South. Verified the position of the "T" iron with record witnesses and measurements from 1981 to present. The position agrees with existing occupation North and South. Found no conflicting evidence in the vicinity of this position. We recommend that the found "T" iron be accepted as the best available evidence of the position of the original government corner and be replaced with a standard Livingston County breakaway monument and brass cap.
