

1993 Gary Koepke, P.S. 26458 (MDOT) found a "T" iron in monument box 20.46 feet Southerly of centerline U.S. 2 and recorded in Liber D, Page 191 of Mackinac County Records.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(B-9) 1/4 Corner Common to Sections 19 & 30, Township 43 North, Range 10 West.

Found "T" iron in monument box as described above. Accepted corner position as found. Corner was to be destroyed during road construction of U.S. 2 and was re-witnessed prior to construction.
