Found 3/4" pipe in mon box per surveys by J. Schafer

Corner M-13 was approved for remonumentation at a Peer Review Committee Meeting on August 17, 1998.

Found 3/4" pipe in mon box per surveys by J. Schafer, set brass cap in 3/4" pipe stamped Midland Co. Remon Cor. PS 29241, and is accepted as the best available evidence of the position of the accepted corner.
