

- A13-M13-A1 & M1 Township Corner common to Sec. 31, T15N, R1W; Sec. 36, T15N, R2W; Sec. 6, T14N, R1W & Sec. 1, T14N, R2W - Fd. 2" ± stake shadow – White sand with organics into light brown sand – and piece of wood stake. Fits remains of witnesses #3 (N32°W 27.6' to Face 24"± PS): #4 (S50°E 71.1'± to face 20"± PS remains to ground) and #5 (N43°E 37.6' to face 30"± Pine Stp.). Witnesses #6 to 9- Rejected corner position. Measured N 21'± vs. 33' GLO to edge of swamp. West 23'± to edge of swamp. No evidence of witnesses #1 or 2. Stake remains and shadow accepted as a careful and faithful reestablishment of the position of the original corner.
 - Reference Pt. Found ½" CIR #47973 is S37°33'E 4.03' of the recovered Gibbs Township corner. ½" CIR not utilized as "A13-M13-A1 & M1" in this survey.
